Facility Rules (please read this section):

Please clean up after your dog. We can not stress this enough! This is NOT a dog training facility, so any poop found around the grounds came from our trials. There are outside garbage cans for this waste.

Please bring a dry/clean pair of shoes to wear in the facility. NO outdoor footwear is allowed in the trial room!

Also, due to crating space limitations, we ask that there be no space between crates. If this might bother your dog, please bring a blanket or something to cover the side of your crate. We may ask you to stack your crate in some areas. We have chairs at the facility, so please do not bring lawn chairs as there is no room for them. Compact, director type chairs are fine to bring. NO x-pens are allowed. As per CKC regulations, only dogs that are entered in these trials are allowed in the trial building.

Late Entries:

As these trials are full, late entries will NOT be available.

In 2010 the Board of Directors passed a motion with respect to a Non-Member Tracking Fee for Canadians that participate in CKC events and are not CKC members. At the December 2010 Board of Directors meeting the Tracking Fee motion was deleted and replaced with the following motion:

Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.”

The Non-Member Participation Fee is effective January 1, 2011. Cost is: \$55.00 + HST

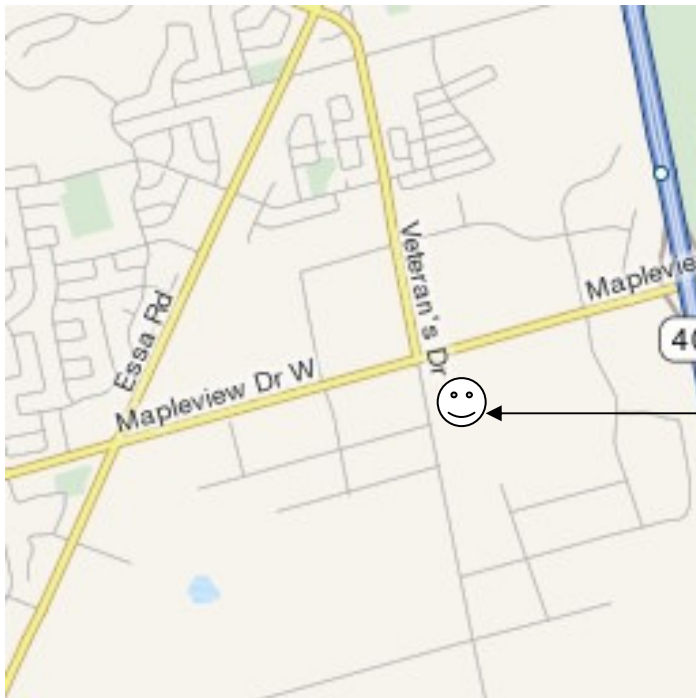
