All dogs must have a CARO Registration Number that must be on the entry forms.

Note: CARO regulations require the owner to obtain a CARO number directly from CARO. If you do not have a CARO Reg. # card for your dog, complete the Individual Dog Application form, found on www.canadianrallyo.ca and submit it directly to Caro. Please note that it takes several weeks to get a CARO Reg. #. A valid CARO Dog Reg. # card must be presented at the trial check-in, otherwise the dog will not be permitted to compete at this trial.

Physically challenged handlers are encouraged to participate. Handlers shall provide the judge with a written description of how they intend to perform any of the course exercises.

Awards

- Qualifying and first through third placement ribbons will be offered. In order to keep entry fee costs down, Red Barn Event Centre New Title Rosettes will be available for purchase. Cost is \$5.00 including HST.

Facilities:

- The trial will be held at the Red Barn Event Centre indoor facility on Top Dog Rubber Agility Flooring with underlay. NO outdoor shoes are allowed in the rubber area. Please bring clean indoor shoes to wear in this area.
- This is a one-ring event. A crating area is available inside the building
- Competitors are responsible for their own crating, seating & dog water.
- Tip & Sip Café will be open before and during these trials. Please support them as we want them to continue to offer their services at the Red Barn.

Dogs:

- All dogs must be kept in a crate or on leash when not in the ring (x-pens are allowed)
- Handlers are responsible to keep their dogs quiet at all times and clean up after their dogs.
- Handlers are responsible to ensure the dogs do not eliminate in the front of the building or on neighbouring areas.
- Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. There will be no refund of fees in such instances.
- Any handler displaying inhumane or aggressive treatment of any dog, or other participants, judges or volunteers, be it physically or verbally, while on site, will be asked to leave the trial grounds. There will be no refund of fees in such instances and all legs earned will be null and void.

- *The Rally Novice A Class.* The A stream is for the handler who is an inexperienced beginner – who has never titled a dog in any sport. They have not instructed or assisted with dog training classes in any sport. In effect, this is the first time they have worked a dog towards a title. Once the handler has obtained their RN title, they may continue on to the Advanced A stream with the same dog. There is no A or B stream in Excellent or Versatility.

When a competitor has attained their first Advanced A title, they are considered “experienced” and must compete in the B stream with any other dogs they handle.

A handler must own the dog entered, or be a member of the owner(s) household or immediate family to compete in Novice A.

A person may enter more than one dog in this class. A dog completing the Rally Novice (RN) title, may continue to compete in this class for practice purposes. “For Exhibition Only” (FEO) Dogs competing under FEO are not eligible for placements in the class.

Move Ups: Will be permitted providing the Trial Secretary is informed in writing at least one (1) week prior to this event. Same day move-ups will be permitted, please note it is the handler’s responsibility to inform the Trial Secretary before their next event.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of the premises upon which the event is being held and their employees, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the premises, grounds, or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claims; and I (we) further agree to hold the aforementioned parties harmless from any claim for the loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person or any other cause or causes.
